Show details:

- This is a juried and judged show open to all paid members of FCPAP.
- The juror/judge will be Allison Watson.
- Regarding paintings not accepted, Carron will contact the artists by the next day and make arrangements to return those paintings.
- Work that has been in a previous FCPAP show is not permitted.
- Awards will be given for 1st, 2nd, 3rd and 4 Honorable Mention awards.
- Thrasher-Horne Center will be printing a program which will include small images of artworks. **NOTE:** These images will NOT be used for jurying.

Preparing to Enter:

- Check that your membership with FCPAP is current.
- Up to 3 entries are allowed per member.
- Ensure all artwork has been done Plein Air with only minor touchup done in the studio.
- Work must be no older than 3 years old.
- Ensure that your painting is dry before drop-off.
- There is no minimum or maximum size.
- Paintings must be framed or gallery wrapped, and ready for hanging (with picture wire, D-rings, no saw tooth hangers). Gallery wrapped must be painted on the sides and have a minimum of 1 ½” depth.
- Fill out the labels in this prospectus and tape to the back of your entries before delivery.

Entering Artwork:

- Mail images of entries to Carron at wedlund1@bellsouth.net by January 21. Put in subject line 'THC entries'. Save each image file with the actual title of the painting followed by your initials. Ex: A Summer Morn_CW. In same email include the title, medium and price.
- Deliver and pay for your entries on delivery, January 24. The fee is \$15 per entry.

From the Thrasher -Horne Center

- All artwork displayed must be available for sale. Special exceptions can be made and must be approved by venue prior to exhibit.
- Thrasher-Horne Center handles sales and takes a 30% commission on sold paintings.
- Artist must replace sold artwork with another piece within 2 weeks.
- The venue requests a \$50 agent's fee on all artwork commissioned as a result of your exhibit with us.
